**provided that :**

- (i) They have been absorbed in BSNL on permanent basis
- (ii) No Disciplinary/Vigilance case is pending against him/her and no VC is withheld in terms of instructions contained in DG P&T/DOP&T from time to time.
- (iii) The currency of any penalty against the officer is over, or
- (iv) The officer is not on deputation to TCIL or any other Organisation.
- (v) The officer has not retired on the date of issue of the order.
- (vi) They have fulfilled the prescribed eligibility of three years of regular service as per SDE (T) RRs.

2. Such cases will be decided by the BSNL Headquarters on receipt of information from concerned units in consultation with Circle Office. Information in this regard may be brought to the notice of this office immediately and the concerned officers should not be promoted or relieved for posting without specific orders from this office.

3. JTOs mentioned above who have opted for DOT or who have not given any option for their absorption may not be promoted. Such cases may be reported to this office.
4. The officers are required to join their promotional assignment within a period of 40 days from the date of issue of BSNL order. The SSA Heads may ensure that the station of posting orders in respect of officers is issued in time to join their promotional assignment and the officer is relieved within the prescribed period of 40 days from the date of issue of BSNL order.
5. In case the officer concerned fails to join the promotional assignment within the prescribed period of 40 days, he/she should not be allowed to be relieved or join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action.
6. The pending request of the officer for modification of the promotion order cannot be taken as ground for holding of the implementation of the promotion order in respect of the officers.
7. The leave, if any, requested by the officers, who have been posted on promotion to different Units, should not be allowed. If any officer desires leave, he/she can apply for leave to new Head of Unit under whom he/she has been posted only after joining their new post and the concerned Head of Unit will sanction leave, if it is considered, justified in normal course.
8. Discrepancies regarding name, gender, present circle etc. in the BSNL Hq. orders may be intimated to this office immediately for onward transmission to BSNL Hq. for further necessary action at their end.
9. The date on which the above order is given effect to may be intimated and a consolidated report of the officers who have been relieved/joined their new postings may also be sent immediately on expiry of 40 days from the date of issue of BSNL New Delhi order.
10. The vacancy/panel years against which the officers are shown as eligible in the above list have been prepared by the BSNL Hqrs. on the basis of the results as per BSNL CO letter No. 5-4/2012-DE dated 28.06.2013 . The seniority of the officers promoted under this order shall be determined in accordance with the rules in force and will be issued separately by the Hqrs.
11. The seniority revision/promotion of officers already working as SDEs (T) under 67% promotion quota are being decided by BSNL Hqrs. and their promotions will be issued separately provided their seniority gets improved under competitive quota on the basis of the results declared vide letter No. 5-4/2012-DE dated 28.06.2013.

12. The aforesaid promotion order is subject to the final outcome / decision in any lawsuit(s) pending before any Court(s) regarding their regulation of seniority/promotion.


13. Officers who are promoted under reservation quota, the correctness of their community may be verified by the respective Unit Heads .

16. Pay fixation on promotion be done as per prescribed norms.
