The SSA Heads are requested to relieve the officers on or before **25.04.2016**, who have been transferred at **company cost**. All the Heads of SSAs are requested to relieve the officers within stipulated time. In case the SDEs are not relieved by their controlling officers, responsibility will be fixed on the concerned Controlling Officers.

Further, the Pay drawing officers of the SSAs are directed not to draw the Pay & allowances with effect from the month of May, 2016 in respect of the SDEs who have been transferred at **company cost**. In case officers are not relieved within stipulated time, Circle Office Bengaluru will relieve the officers from ERP.

In respect of the SDEs at Sl no 14 to 31, who have been transferred on their long stay basis during 2014, Heads of SSAs are requested to relieve the SDEs after completion of **prescribed tenure period two (2) years**.

If any of the officers ordered looking after arrangements in the STS grade, they must be reverted to substantiate grade before implementing the transfer order.

The leave, if any requested by the officer who is/are under transfer should not be allowed. However in case any officer desires leave, he/she can apply for leave to the competent authority only after joining the assigned place of posting.

Further, the SSA/Unit is instructed that before relieving the officer, it must be ensured that:

- a) Relieving action should be run in HCM-ERP.
- b) The officer should clear all pending works in the ERP inbox.
- c) ERP Roles and Authorization of the officer should be disabled.
- d) Temporary advances if any should be closed.
- e) APARs of the subordinates should be completed in all respects.
- f) Self appraisal of the officer till date to be submitted to the reporting officer.
- g) EMRS card, Identity card should be surrendered. Furniture, Lap Top and Service Mobile instrument are also to be surrendered to the concerned authority.
