## MINUTES OF THE MEETING

The following issues were discussed in the meeting:

  - 4.AIGETOA Karnataka Circle conference and Conduction of AIC at Mysore:

it is decided to conduct circle conference and reorganize the Circle body of Karnataka circle as the current circle body period is ending on 3<sup>rd</sup> Sep 2016.
