Sub: Rule-08 Transfers, Posting of LICE Passed JTOs and Intra Circle Transfers-reg.

The following points are submitted for your favorable consideration:

1) Rule-08: There are 93(11 LICE#1+ 82 LICE#2) TTAs who have passed LICE and either joined or going to join as JTOs in Karnataka Circle in few days. Last year, 64 R-8 cases were approved and only 54 got relieved from Karnataka Circle. Hence we request you to consider 103 (93+10) JTO Rule-08 transfer

We reiterate that JTOs are away from their home for long period with lot of family problems so Rule-08 must be executed on priority. Getting school admission is very difficult if they reach their home town next month so we request you to relieve the approved 74 cases immediately and also we request you to consider left out 29 cases (103-74) in due course.

Substitute for the above cases may be 50% from LICE passed JTOs and 50% from long standing JTOs.

2) Posting of LICE Passed JTOs: Some percentage of vacancies should be kept open for these JTOs in all batches and they should be given option for posting to SSAs of their choice. Denying them an opportunity to work in SSAs with revenue potential will not benefit the organization in the long run.
