विषय/Sub: Promotion and posting of JTOs to the grade of SDE(Telecom) in BSNL under Competitive Quota (33%) on the basis of Limited Departmental Competitive Examination (LDCE) held on 21.06.2015-reg.

In pursuance of BSNL office order No.2-16/2013-Pers.II dated 25.5.2018 and BSNL Corporate Office's Recruitment Branch letter no. 24-1/2014- Rectt. Dated 20.4.2015 and 24-3/2015-Rectt(Pt) dated 15.5.2018, the competent authority is pleased to promote the JTOs as per Annexure enclosed against 33% Competitive quota to the grade of SDE(Telecom) against vacancies year 2010-11 under competitive quota (33%) in the IDA Pay Scale (E2A) of Rs.20600-46500/- from the date they assume charge of the higher post provided that

- They have been absorbed in BSNL on permanent basis
- No disciplinary/vigilance case is pending against him/her and no VC is withheld in terms of instructions issued by DGP&T / DOP&T from time to time.
- The currency of any penalty against the officer is over .The officer is not on deputation to TCIL or any other organization
- The officer has not resigned from the BSNL services
- They have fulfilled the prescribed eligibility of three years regular service as per SDE(T) RR.

2. This office will decide such cases as detailed in Para I supra on receipt of information from the concerned Sub regions. Information in this regard may be brought to the notice of this office immediately and the concerned officer should not be promoted or relieved for posting without specific order from this office.

3. PGMs/GMs may issue the promotion order **subject to the vigilance clearance** and submission of **necessary undertaking** in the prescribed Format (enclosed) as per the direction of Hon'ble CAT Chandigarh Judgement in OA No.060/00133/2015.

4. All PGMs/GMs may ensure that the promotion/posting orders in respect of officers found eligible after fulfilling the above conditions are issued in time to enable the officers to join the promotional assignment, within the prescribed time limit of 40 days (including the joining time) from the date of issue of BSNL CO order.

5. In case any officer failed to join the promotional assignment within the period of 40 days he or she should not be allowed to be relieved or joined the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further action.
6. Subsequent to the promotion to the grade of SDE(T) Corporate office shall consider the request of transfer to other Territorial/Non Territorial circle as per the administrative requirement and the availability of vacancy.
7. Discrepancies, if any, regarding Name, Present Circle etc. in the Annexure may be intimated to this office immediately for issuing modification/corrigendum.
8. The date on which the above order is given effect to may be intimated and a consolidated report of the officers, who have been relieved /have joined their new postings may also be sent immediately on expiry of 40 days, from the date of issue of BSNL order. Copies of Charge Report may be marked to all concerned.
9. The seniority of the officers promoted in this order shall be determined in accordance with the rules in force and will be issued separately.
10. This promotion order is subject to the outcome of final decision in any law suits pending before any courts regarding the regulation of seniority etc.
11. The relieving and joining particulars of officers may be updated in the ERP.
12. The pay fixation on promotion be done as per prescribed norms.
